Dressage

1st & 2nd placed team and 1st & 2nd placed individuals from each section will qualify for the NSEA National Schools Championships in October 2023

Class 1 Prelim = P 13 (2006) Team & Individual Qualifier

Class 2 Novice = N 28 (2008) Team & Individual Qualifier

Class 3 Elementary = E 50 (2007) Individual Qualifier Only

Teams shall be made up of 3 or 4 riders, best 3 scores to count. Up to two riders to compete in the prelim test and up to two riders in the novice test. All team riders will automatically count for individual placings providing they are eligible.

Please note that Dressage tests at the Championships will be:

Championship Individual Tests 2022 all ridden in 20x60m arenas:
Prelim 17A (2017), Novice 37A (2017), Elementary 55 (2019),

Championship Team Tests 2022 all ridden in 20x40m arenas:
Team Tests = Prelim 14 (2006) revised collectives 2016 (up to two riders), Novice 34 (2009) (up to two riders)

Entry Fee £22.00 per class

Eventers Challenge

1st & 2nd placed teams and 1st to 4th placed individuals qualify for NSEA Eventers Challenge Final at Hickstead in May 2023

Class 4 Mini 70-75cm Team & Individual (Hickstead qualifier). Single phase.

Class 5 Novice 80-85cm Team & Individual (Hickstead qualifier). Single phase.

Class 6 Intermediate 90-95cm Team & Individual (Hickstead qualifier). Single phase.

Class 7 1.00-1.05m Open Team & Individual (Hickstead qualifier). Single phase.

Teams of 3 or 4 competing at the same height, best 3 scores to count. All team riders will automatically count for individual placings providing they are eligible. This competition is open to schools from all counties and will also count for RPL points.

The Course is made up of SJ & simulated XC fences with an optimum time & no style marks. Larger arenas may use secured XC portables. Riders will jump a series of show jumps and then proceed immediately into the XC phase which is run on an optimum time of 350- 375m/m.

Entry Fee £33.00 per class

NSEA Eventers Challenge Rules for Scoring 2022-23

The intention of these rules is to reward riders who have a clear round and to penalise riders who have jumping penalties or who are significantly faster than the Optimum Time. Where there are several competitors with a clear round, then the nearest to the Optimum Time will win, rewarding an appropriate judgement of pace around the course.

EC1) Open to Teams and Individuals

- Riders will jump a course of 5-8 show jumps and then proceed immediately into the XC phase of 8-15 simulated XC fences, depending on the size of the arena.
- The speed for the XC phase will be between 320m/m to 375m/m depending on the size of the arena – smaller arena = tighter turns which slow you down. A larger arena with flowing lines will ride on a quicker time. The speed for each class will be given in the schedule or on the noticeboard at the event. Times will be recorded to one-hundredth of a second if the timing equipment allows.
- NSEA/BE Eventing Rules for tack and rider equipment for XC.
- There will be no style mark. No age restriction on the mini (70/75) class.
- Top two teams and 4 Individuals at each height to qualify for the NSEA Eventers Challenge Championship to be held at Hickstead in May.

EC2) Dress: XC colours, body protectors are compulsory. Hair must be above collar length, long hair to be kept in place in a hair net. Rider must wear BE approved skull caps, no fixed peak SJ hats.

EC3) The competitor with the fewest penalties wins. In the event of a tie, the competitor closest to the optimum time will be the winner. In the team competition, the total of the best three scores is used to place the team. The combined difference from the Optimum Time of the 3 best scores is used to break any ties.

EC4) The top 2 teams & 4 individuals at each qualifier will qualify for the NSEA Eventers Challenge Championship.

EC5) Organisers are asked to ensure that the XC phase includes elements that give a choice about the track and therefore the time taken. Organisers are asked not to display a clock showing the time taken visible to the rider to as the aim is to educate riders to ride by feel.

Penalties are awarded as follows

Knockdown (to include SJ and knockable xc fences)	4 penalties
1st Refusal	4 penalties
2nd Refusal	8 penalties
3rd Refusal	Elimination
Rider Fall	Elimination
Horse Fall	Elimination
Starting before the bell, retaking an obstacle already jumped, error of course or outside assistance	Elimination
Where the Optimum Time is 120 seconds or less, for every commenced second in excess of 10 seconds under the optimum time	1 penalty
Where the Optimum Time more than 120 seconds, for every commenced second in excess of 15 seconds under the optimum time	1 penalty
Exceeding time limit (2 times the Optimum Time)	Elimination

DISCLAIMER

The organisers reserve the right to eliminate any competitor whose riding helmet is not fastened when mounted. Riding helmets must bear the current safety standards for the discipline in which you are competing. The organisers strongly recommend that competitors wear body protectors and hairnets, for eventer challenge these are compulsory. The organiser of this event has taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the organisers, officials and stewards. Any damages must be paid for. Vehicles, boxes and trailers and are parked entirely at the owner's risk. Anyone entering this competition will be deemed to have agreed to abide by the rules in this schedule and NSEA 2022-23 rules. All schools to provide their own arena party when their pupils are competing. The organisers reserve the right to cancel the event, in which case entry fees will be refunded (less £5 per competitor). In the event of adverse weather conditions, the competition will be rescheduled. Competitors will only be able to walk the course at the beginning of each class or during specified times.

Your Responsibility

All persons attending the event must take all reasonable precautions to avoid and prevent accidents and must obey instructions given by the Organiser or by officials and stewards on its behalf. All competitors and those associated with their school are the responsibility of the Team Manager whilst at the competition. All enquiries are to be made by the Team Manager please.
