Class 1 40cms Team & Individual Grass Roots Qualifier (may be led/assisted) Judged on style. Not timed

Class 2 50cms Team & Individual Grass Roots Qualifier (may be led/assisted) Single phase

Class 3 60cms Team & Individual Grass Roots Qualifier (may be led/assisted) Single phase

Class 4 Mini 70-75cms Team & Individual SJQ
(Riders to be aged under 14 on 1st January 2023)
Single phase. All team riders automatically count as individuals.

Class 5 Novice 80-85cms Team & Individual SJQ
Single phase. All team riders automatically count as individuals

Class 6 Intermediate 90-95cms Team & Individual SJQ
Single phase. All team riders automatically count as individuals

Class 7 1m-1.05m Open Team & Individual
Single phase. All team riders automatically count as individuals

Class 8 1.10m Advanced Open Team & Individual
Single phase. All team riders automatically count as individuals

Entry Fee £23.50 per class, including paramedic cover

Rules and Conditions

- Outside assistance will NOT be tolerated and could result in Elimination
- NSEA affiliated competitors only may warm up & compete horses on the show ground
- All competitions, parents and representatives from every school must ensure that they act courteously to stewards and officials at all times Most of them are volunteers and rudeness is not acceptable. Have a good day!
- To be run in accordance with NSEA Rules
- all participants undertake activities at NSEA events at their own risk. Please ensure that you seek and act upon any appropriate medical advice which you receive before undertaking any activity at the event
- you are strongly advised to acquaint yourselves with the terms of the NSEA insurance cover which is provided to all registered riders and the team manager of member schools; and we will not be liable for any acts or omissions of our employees, agents and sub-contractors in relation to any activity at NSEA events or for any loss or damage suffered by you as a result of taking part in any activity at NSEA events.
- It is mandatory for all riders to wear a protective helmet to British standard EN1384 or PAS015 at ALL times while mounted.
 - Horses and Ponies MUST NOT be tied to the side of horseboxes or trailers and left unattended – please clear up any mess left by you or your horses

Indoor arena up to 4 horses at anytime

- Outdoor arena up to 6 horses at anytime
- Hirer must ensure their event is covered by suitable insurance and must indemnify Suffolk Rural College against any claim for accidents, injury, loss or similar, however caused to either horse, rider or spectator
- Due to circumstances beyond Suffolk Rural College’s control it may be necessary to change or cancel bookings. You will be offered the option to accept the change or to receive a full refund of any monies paid against the booking
- Suffolk Rural College is not responsible for any other costs, expenses or damages which may have been incurred by the client or their guest as a result of the change

Suffolk Rural College reserve the right to halt any actions which we consider to be contrary to our Health and Safety policy or which we consider to be unsafe

Access from car park to arena for horses is only via the metal gate – Not the wooden gates.

- Indoor and outdoor school doors or gates must be kept shut when riding or ground schooling
- Outdoor arena gates must be shut and secured with the strap provided after use
- All gates must be kept shut at all times
- Litter is to be taken home or disposed of in bins

□ Children under 16 years are to be supervised at all times

• **Vaccinations:** Horses and Ponies must be accompanied by their passport and must have Equine Flu vaccinations in date within 12mths. Spot checks may take place.

• **Smoking:** - No SMOKING ON SITE

• All competitors/owners and their guests are required to adhere to commonly accepted standards of decency and good behaviour. Racial abuse, discrimination, swearing and loud or aggressive conduct will not be tolerated.

• **No mucking out** onto the car park,. The Car park and walkway must be poo picked, a wheel barrow and poop scoop are An immediate fine of £20 will apply if this is seen to take place.

• Litter is to be taken home with you or disposed of in the big bins provided. Please use recycling bins if provided.

Children under 16 must be supervised at all times.

Please return any equipment used back to its storage area after use

DOGS – STRICTLY NO DOGS

Vehicles - The Show Organiser reserves the right to remove any vehicle which is obstructing any access to or from the ground even if locked and unattended. The Show Organiser will not be liable for any injury, loss or damage occasioned by such removal.

Prize Givings –There will be no prize givings, ONE member from your school may collect rosettes.

Objections – Objections should be made in writing within 1hr of the incident taking place and be accompanied by a £50 deposit that will be returned if your objection is upheld.

First Aid – A total of £3 per competitor per day.

. **Stallions** – No person shall allow a stallion for which he/she is responsible as owner, lessee, authorized agent or rider to compete or be prepared to compete, in any class without taking adequate precautions to ensure other persons are not put at risk of injury.

Close of Entries – Entries will close on the official closing date. Should space be available late entries may be accepted. Entry to the show constitutes your agreement that you, and those associated to you agree with, and are bound by the rules in this schedule

Your Responsibility

All persons attending the event must take all reasonable precautions to avoid and prevent accidents and must obey instructions given by the Organiser or by officials and stewards on its behalf.

All competitors and those associated with their school are the responsibility of the Team Manager whilst at the competition

The NSEA will not be held responsible for any financial loss incurred by the attendee as a result of a cancellation.
