Class 1 Mini 70-75cm Team & Individual JwS Qualifier

(Riders to be aged under 14 on 1st January 2023)

All team riders automatically count as individuals.

Class 3 Novice 80-85cm Team & Individual JwS Qualifier
All team riders automatically count as individuals.

Class 5 Intermediate 90-95cm Team & Individual JwS Qualifier.
All team riders automatically count as individuals

Class 7 Open 1m-1.05 Team & Individual JwS Qualifier
All team riders automatically count as individuals
