**DRESSAGE:** Dressage tests are the British Eventing tests which are available to download for free from www.britisheventing.co.uk/downloads.

**Classes will not necessarily run in this order as it will be dependent on entries.** Dressage will be on grass and the Show Jumping will be on a surface.

Prizes: Prizes in Kind. Individual Rosettes 1st -10th place. Team rosettes 1st - 6th place in each class.

#### **ENTRIES**

Entries will be taken on a first come first served basis. Entries on-line only at <u>www.westwilts.com</u> by midday Thursday 11<sup>th</sup> July 2024.

**ENTRIES CLOSE Thursday 11<sup>th</sup> July 24 or earlier if full**. Late entries if space allows up to 9am Thursday 18<sup>th</sup> July. £10.00 LATE ENTRY FEE. Team Entries <u>MUST</u> be emailed to us no later than 9am Thursday 18<sup>th</sup> JULY 2024.

ANY changes to horse, rider or class entered after 11<sup>th</sup> July will be subject to a £10 admin fee. Change of horse and rider constitutes a new entry. No entry is accepted without the payment.

**Withdrawals:** A refund, less £10.00 admin fee, will be made for withdrawals made via email before the close of entries on Thursday 11<sup>th</sup> July 2024. All withdrawals to be made via email – info@westwilts.com

After the initial close of entries (Thursday 11<sup>th</sup> July 2024) no refund will be given unless replaced from the waitlist. These refunds will be subject to a £10.00 admin fee.

# In case of abandonment (or cancellation of event due to any infectious disease) entry fees will be returned less £15.00 abandonment fee per entry – start fees will be refunded in full.

**START TIMES:** All times and Numbers will be available on www.nsearesults.co.uk 2 days before the competition.

#### **CONDITIONS of ENTRY and RULES:**

All schools & riders must be affiliated to NSEA.

These horse trials will be run according to the rules of British Eventing, except where varied below and the making of an entry constitutes acceptance of those rules.

\*Horses/Ponies must be 4 years of age or older.

\*Riders must be at least 11 years of age for 100 and 10 years of age for 90. There is no minimum age limit for 80. \*Points won in B.E. events will not apply.

\*Hard hats must be worn to BE/PC/RC standards and must be tagged with new PINK Tag (2023 onwards).

\*Body protectors must be worn when competing in the cross country phase and must be of the current British Eventing standards.

\*Competitors should wear medical arm bands if they have anything they need to disclose to paramedics in event of a fall. \*Any horse or pony, which is considered by a Judge or the Organisers to be too small for the jockey, unsound, unfit or unhealthy, will be excluded from further competition without any refund of entry fee.

\*ATV's and motor-bikes are not permitted, unless specifically authorised by the Organisers.

\*All dogs must be kept on short leads.

\*All competitors will be required to print their own numbers, so each rider will require a bib to display their number.

\* The organisers reserve the right to refuse any entry. No horse or pony may compete in more than one class.

#### PASSPORTS/VACCINATION CERTIFICATES - MINIMUM OF WITHIN THE LAST 12 MONTHS

A passport/vaccination certificate with a complete history **MUST** be brought with the horse/pony. Please ensure that the name of the entered horse matches with the name on the Certificate and that you allow sufficient time for the certificate to be checked. Please check WWEC current vaccination policy. No changes will be allowed on the day in the event of Vaccinations failures.

#### COURSE

There are 4 courses, all over fixed fences and approximately 2 km on permanent pasture.

All competitors are responsible for making way for and not impeding overtaking competitors. Inconsiderate riding leading to obstructing another competitor could lead to elimination at the Steward's discretion.

ELIMINATION AND RETIRING: Any competitor who is eliminated or who retires must leave the course immediately at a walk.

**Walking the course.** The course will be open for inspection on foot only from 2 pm until 6pm on the Saturday before the competition or on the competition day.

**RESULTS:** The winner will be the competitor with the least number of faults. Results will be posted online at <u>www.eventingscores.co.uk</u>

HATS & BODY PROTECTORS Everyone mounted, whether competing or not, must wear an appropriate hard hat (to comply with current BE Rules and tagged with a PINK hat tag). For the cross country element body protectors are obligatory as per the BE approved list (See current rule books) Half chaps/matching boots may be worn

#### **QUERIES OR OBJECTIONS**

Objections must be made within 15 minutes of posting the results via the Secretary with a fee of £20, which will be payable if the objection is not upheld.

#### DISCLAIMER OF LIABILITY

Neither the organisers nor the sponsors accept any liability for any accidents, injury, illness or damage to or by horses, owners, riders, spectators, ground or any persons or property whatsoever. We strongly recommend that all persons entering West Wilts have Third Party Insurance in order to protect themselves from injury or damage compensation claims caused by them or their animals.

#### HEALTH AND SAFETY

The Organisers of this event have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the Organiser, Officials and Stewards. You are politely requested to comply with the requests of any Official in order to ensure the safety of yourself and others while attending the event. Third Party Liability insurance for horse and rider is strongly recommended.

#### GENERAL

Horses can easily be frightened and can be dangerous. All pedestrians are requested to keep clear from horse areas/lanes and to avoid behaviour that might alarm horses. Dogs MUST be kept on a short lead at all times.

Emergency Services must have access to all parts of the event site at all times and attendees/ public must not park vehicles so as to obstruct access.

**Disability Notice** Any person attending the event who suffers from a disability and/or have a wheeled disability conveyance should park in the area designated for disabled parking. Access to the XC course will be limited for safety reasons. Disability wheeled motorised conveyance owners should ensure they have third party liability insurance cover.
