(Riders to be aged under 14 on 1<sup>st</sup> January 2023)

All team riders automatically count as individuals.

Class 3 Novice 80-85cm Team & Individual Qualifier

All team riders automatically count as individuals.

Class 4 Intermediate 90-95cm Team & Individual Qualifier.

All team riders automatically count as individuals

Class 5 Open 1m-1.05 Team & Individual Qualifier

All team riders automatically count as individuals

Class 6ab Advanced 1.10 Individual Qualifier a) horses and b) ponies
