1st & 2nd placed team & 1-4th placed individuals will qualify for the NSEA National Schools Championships 2024

Entries Close: Tuesday 27th February (or earlier if classes are full)

DRESSAGE

Tests at Championship Qualifiers 2024 (Team & Individual) all in 20x40m arenas as follows.

Class 1 Prelim = P 13 (2006) Team & Individual Qualifier

Class 2 Novice = N 28 (2008) Team & Individual Qualifier

Class 3 Elementary = E 50 (2007) Individual Qualifier Only

Entry Fee £18 per test

Teams

Teams shall be made up of 3 or 4 riders, best 3 scores to count. Up to two riders to compete in the prelim test and up to two riders in the novice test. All team riders will automatically count for individual placings providing they are eligible (see NSEA 'Additional rules)

The top 2 teams & 2 Individuals per section will qualify for the Championships

Please note that Dressage tests at the Championships will be:

Championship Individual Tests 2024 all ridden in **20x60**m arenas Prelim 17A (2017), Novice 37A (2017) Elementary 55 (2019),

Championship Team Tests 2024 all ridden in **20x40**m arenas Team Tests = to be announced closer to the Championships

COMBINED TRAINING

Bury Farm will be running dressage qualifiers and show jumping qualifiers at the 3rd March show.

To enter the combined training, competitors will complete a dressage test and a showjumping round at the show. Competitors pay £5 over and above the dressage and showjumping entries to cover the combined training entry fee.

To enter the dressage phase of the combined training please enter class 1 – Prelim 13. This class is also a team and individual only dressage qualifier.

To ensure that the entry into class 1 is also treated as the dressage phase of the combined training competition, please enter class 4, 5 or 6 depending upon the showjumping height selected

The dressage test will be ridden before the showjumping round wherever possible.

Tests at Championship Qualifiers 2024 (Team & Individual) all in 20x40m arenas as follows.

The top 2 teams and 4 individuals qualify for the NSEA Championships in each class

Class 4 Combined Training Prelim Qualifier

Prelim = P 13 (2006) SJ 80cm NoviceTeam & Individual Qualifier

Class 5 Combined Training Intermediate Qualifier

Prelim = P 13 (2006) SJ 90cm IntermediateTeam & Individual Qualifier

Class 6 Combined Training Open Qualifier

Prelim = P 13 (2006) SJ 1m Open Team & Individual Qualifier

Bury Farm Terms and Conditions

By entering any equestrian class or competition run or held at Bury Farm EC you acknowledge that you are taking part in a risk sport and are a competent rider at the level to which you are competing.

Please refer to our Show Rules & Conditions of Entry.

The Bury Farm team looks forward to welcoming competitors back to the centre. As the health and safety of all visitors is paramount please ensure that you have read the below information as you will be asked to comply with these guidelines during the course of your visit. Bury Farm reserves the right to ask competitors to leave the centre if any of the below guidelines are breached.

Entries for Bury Farm shows must be made online via the event link on the Events Tab of the Bury Farm website, www.buryfarmequestrianvillage.co.uk. Entries will not be accepted after the closing date unless space allows.

Bury Farm will issue refunds for entries in line with NSEA rules. Withdrawals need to be made in writing and emailed to dressage@buryfarmestates.co.uk. Refunds will not be offered after close of competition entries. A transfer of entries may be considered if the competitor emails dressage@buryfarmestates.co.uk prior to the show times being published. Bury Farm reserves the right to charge an administration fee for any refund or transfer of entries.

The Paddocks cafe team will provide a service on the day of competition and will be offering a selection of hot food, drinks and snacks.

Competitors may not access the livery facilities during their visit to the centre.

In line with biosecurity measures please have your passports available for inspection upon arrival at the centre. Horses must have up-to-date vaccinations and the organisers reserve the right to turn horses away from the competition if proof of vaccination records cannot be presented upon arrival.

BIOSECURITY MEASURES

All horses must be travelled with passports which can demonstrate that all vaccinations are up to date (Bury Farm operates a 12-month vaccination policy)

Horses must also show no clinical signs of the following when attending the centre:

- 1. recent cough of unknown cause
- 2. recent nasal discharge of unknown cause
- 3. enlarged lymph nodes
- 4. fever (>38.5 degrees)
- 5. recent onset of neurological signs of unknown cause
- 6. diarrhoea

Horses must also

- 1. not be under current investigation for EHV infection
- 2. have not been in contact with and is not kept on the same premises as a horse known to have or be under investigation for EHV
- 3. have not travelled out of the country for the past 28 days.

Horses should NOT be brought to the centre if they are not in good health on the date of travel.

- 1. The decision of the judges & stewards in all cases is final. They reserve the right to alter, amend or cancel any part of the competition or to refuse any entry without stating a reason.
- 2. The organiser of this event has taken reasonable precautions to ensure the health, safety and welfare of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring, and must obey instructions of the organisers, officials and stewards.
- 3. The organisers will not be held responsible and accept no liability for any accident, loss, damage, injury or illness to horses, owners, rider, spectators, vehicles or their contents and accessories, breach of contract or in any other way whatsoever. It is a condition of entry that each entrant shall agree to indemnify against any legal action arising from such incident.
- 4. All competitors must be suitably dressed in correct riding attire to current British Safety Standards. Riding / Jodhpur boots must be worn for all classes.
- 5. Horses & ponies tied to lorry or trailers must not be left unattended.
- 6. Please ensure the area around your horsebox / trailer is clean and tidy. Droppings collected and not swept onto or left on BFEC. Please take litter home or use the bins provided.
- 7. Children must be supervised at all times
- 8. Whilst outside arenas, horses and ponies should be moved at a walk only.

- 9. There is a vet on call. The expense of any veterinary services rendered either on or after the show must be borne by the competitor or owner of the horse / pony.
- 10. No dogs allowed, other than in Lorry Park Only and MUST be on a lead at all times
