Show Jumping Classes:-

Warm up 60cm Clear Round. A clear round rosette will be given to all clear rounds in this class. £20 per competitor

Class 1 Mini 70-75cm Team & Individual Qualifier £25
(Riders to be aged under 14 on 1st January 2024)
Single phase. All team riders automatically count as individuals.

Class 2 Novice 80-85cm Team & Individual Qualifier £25
Single phase. All team riders automatically count as individuals.

Class 3 Intermediate 90-95cm Team & Individual Qualifier. £25
Single phase. All team riders automatically count as individuals

Class 4 1m-1.05 Open Team & Individual Qualifier £25
Single phase. All team riders automatically count as individuals

Class 5 1.10m Advanced Horse Open Individual Qualifier £25
Single phase. Individuals only

Class 6 110cm Advanced Pony Open Individual Qualifier £25
Single Phase. Individuals only

Jumping with Style classes:-

Warm up 60cm - Clear round only, no placings. Rosettes to clear rounds

Class A Mini 70-75cm Team & Individual Qualifier
(Riders to be aged under 14 on 1st January 2024)
All team riders automatically count as individuals.

Class B Novice 80-85cm Team & Individual Qualifier £30

All team riders automatically count as individuals.

Class C Intermediate 90-95cm Team & Individual Qualifier £30

All team riders automatically count as individuals

Class D Open 1m-1.05 Team & Individual Qualifier £30

All team riders automatically count as individuals

Class E Advanced 1.10 Individual Qualifier Horses Only £30

Class F Advanced 1.10 Individual Qualifier Ponies Only £30

Paramedic Fee is £5 per rider - please pay when you enter.

Start Times will be available on Northern Equine Event Facebook page and the NSEA website at least 2 days before the competition www.nsea.org.uk

Numbers are available from the secretary sited by the arena. You will need a bib for all classes numbers and numbers must be returned to the secretary please after use.

Prize givings will be held approximately 20 mins after the results have been announced. Prize giving will take place by the NSEA Secretaries tent. All results will be available on Eventing Scores and must be checked by the competitors prior to Prize Giving. Any discrepancies must be told to the secretary before the Prize Giving takes place. Once Prize Giving has commenced, scores are final and cannot be challenged.

Passports must be shown when you are collecting your number and before the horse/pony has come down the ramp.

NSEA Competitors must not mix with the BE competitors. You will be given separate parking and separate warm up arena's. Please strictly keep to your designated areas.

Please make sure that the Paramedic Fee is paid - one per rider per day, regardless of the number of classes entered, this is paid for at the time of entering.

Refunds:- No refunds or transfers after entries have closed. Any refund request prior to close of entries will be subject to a £5 admin fee per competitor. If Northern Equine Events needs to cancel for any reason, entries will be transferred to a different competition.
