Terms and Conditions

The competition will be run under the British Show Jumping Rules 2024 & NSEA Rules as set out on the NSEA website, but the organiser has the discretion to change the rules, if it is required. **N.B. The NSEA 30cm Rule applies to all classes.**

The best three scores will count in the team competitions. Rosettes awarded to 6th place for teams and to 10th place for individuals in all classes. All riders are to be from the same school.

School logos are permitted.

Riders must be in full time education at the school/college they represent in the 2024/25 academic year and 18 or under on 1st January 2024.

A rider may only compete once in any team, and therefore cannot compete two horses in the same team.

Horse/rider combination may only compete in a maximum of two classes.

A rider may not compete in both classes 1 and 5.

Team members will automatically also be entered as individuals and their score, gained whilst riding as a team member, will also automatically count as their individual score when determining the individual placings.

A two-minute warning given to riders not ready to jump at their allotted time before elimination.

Objections must be made in writing, accompanied by a £20 deposit, by the TEAM MANAGER within 5 minutes of the end of the class.

Only the TEAM MANAGER is to deal with the secretary.

There will be **no refunds** 14 days prior to the event, 3rd November 2024

Declarations are to be made 15 minutes before the class starts. There will be no changes to declared entries after the class has begun.

Dogs are not allowed anywhere on site.

Neither the organizers nor any person acting on their behalf accept any liability for any loss, damage, accident, injury or illness to horses, riders, spectators, or any other persons or property whatsoever.

The organizer of this event has taken reasonable precautions to ensure the health and safety of everyone present.

For these measures to be effective, everyone must take precautions to avoid accidents and must obey the instructions of ALL the officials and stewards.

Please bring valid horse/pony passports with necessary vaccinations shown. Spot checks will be performed. Vaccinations to be 12 months.

Anyone in breach of this will be eliminated and asked to leave.

Your Responsibility

All persons attending the event must take all reasonable precautions to avoid and prevent accidents and must obey instructions given by the Organiser or by officials and stewards on its behalf.

**All competitors and those associated with their school are the responsibility of the Team Manager whilst at the competition

Outside assistance will not be tolerated- and could result in elimination.
NSEA affiliated competitors only may warm up & compete horses on the show ground

All competitors, parents and representatives from every school must ensure that they act courteously to stewards and officials at all times. Most of them are volunteers and rudeness will not be tolerated and may result in elimination. Parking is tight so please follow guidance given by our parking attendants. Horses/ponies MUST NOT be left tied to trailers without supervision. Please do not feed hay outside of lorries/trailers in order to keep the parking area clean. Warmup arena is limited to 6 horses/ponies, this will be run in order of jumping.

In the event of cancellation, your entry will be refunded less £8 per horse admin fee.

WWEC Terms and Conditions

Any visitor who displays any symptoms or suspects they may have contracted Covid-19 must not attend the venue. ALL horses must not be under current investigation for infectious diseases including, for example, Equine Herpes Virus (EHV), Equine Influenza, Strangles. All Horses must not have been in contact with and cannot be kept on the same premises as a horse known to have or be under investigation for the neurological form of EHV, Equine Influenza, Strangles or Equine Viral Arteritis. All activity will be in accordance with the advice from the relevant national body, and ANY social distancing guidelines must always be adhered to. HORSES/PONIES MUST NOT BE LEFT TIED UP OUTSIDE UNATTENDED. All competitors will be limited to 4 supporters per horse. No other person(s) should be in attendance. Please do not park in front of or block access to the loading bay. NO spectators or filming are allowed in any of the warm-up or competition arenas. Please use viewing areas. No scoreboards or screens will be used on event and all scores/results will be published online at the end of the day. PLEASE CLEAR UP ANY DROPPINGS OR HAY IN THE LORRY PARK.
