Entry Fee £18 per class

Class 1A County Prelim Restricted Teams (3 or 4 riders)

open to 3/4 x prelim riders that have never ridden above BD bronze prelim level, any novice level dressage (affiliated or unaffiliated,) open pony club or novice BE eventing.

Test: BD Prelim 1 (2024)

The winning team from each respective county will represent their county at the NSEA Inter County Finals.

Class 1B County Prelim Restricted Individuals Only (for riders not in teams)

(2 x prelim riders & 2 x novice riders)

Teams of 3 / 4 riders, best 3 % scores to count

Class 2C County Individual Novice Qualifiers (for riders not in teams)

Test: BD Novice 2 (2024)

Open to rider/horse combinations not to have competed at BD Medium level or above or BE Intermediate level.

The winner from each respective county will represent their county at the NSEA Inter County Finals.

Class 3 Combined Training Individual Novice Qualifier

Prelim = BD Prelim 2 (2024) SJ 80cm

Class 4 Combined Training Intermediate Qualifier

Prelim = BD Prelim 2 (2024) SJ 90cm

Class 5 Combined Training Open Qualifier

Prelim = BD Prelim 2 (2024) SJ 1m

Teams 3 or 4 riders, jumping two different heights. Best 3 scores to count.

1 & 2 Novice Teams (2 x 80 & 2 x 90 riders)

2 & 3 Open Teams (2 x 90 & 2 x 1m riders)

NSEA Rules 2024-25

For 2025, there will be TWO team mixed height sections and THREE Individual qualifying sections.

Teams are made up of 3 or 4 riders

1 Combined Teams Intermediate/ Novice (2 riders jump 80cm and 2 riders jump 90cm)

2 Combined Teams Open /Intermediate (2 riders jump 90cm and two riders jump 1m)

Team riders will automatically count as individuals.

All riders will ride the same test BD Dressage Test Prelim 2 (2024) before jumping in 3 height sections 80, 90 and 1m.

JWS (Arena Eventing) National Qualifiers & EC Qualifiers

Entry Fee £24

by request, these classes will also count for EC Qualifies for Hickstead

Class 6 Mini 70-75cm Team & Individual Qualifier

(Riders to be aged under 14 on 1st January 2024)

All team riders automatically count as individuals.

Class 7 Novice 80-85cm Team & Individual Qualifier

All team riders automatically count as individuals.

Class 8 Intermediate 90-95cm Team & Individual Qualifier.

All team riders automatically count as individuals

Class 9 Open 1m-1.05 Team & Individual Qualifier

All team riders automatically count as individuals

Class 10ab Advanced 1.10 Individual Qualifier a) horses and b) ponies
